- Token Allocation: The total supply of UFCA tokens will be allocated as follows:
  - IEO (Initial DEX Offering): 15% (15,000,000 UFCA)
    - Purpose: To raise initial capital through decentralized exchanges, facilitating early liquidity and broad distribution.
  - Scientific Research (AI ∞ Development): 20% (20,000,000 UFCA)
    - Purpose: Dedicated to funding the continuous research, development, and innovation of the Al ∞ Initiative, including Al Synthara and future Al-driven technologies.
  - Foundation (Including Shareholder Dividend): 20% (20,000,000 UFCA)
    - Purpose: To safeguard the long-term operational integrity and strategic development of the project, ensuring sustainability and aligning with the interests of long-term stakeholders, including provisions for shareholder dividends as per company structure.

- UIFCA Wealth Academy (Education & Research Development): 10% (10,000,000 UFCA)
  - Purpose: Allocated for the development and enhancement of educational programs, curriculum expansion, and academic research within the Academy.

#### 3.4. Token Distribution and Vesting Schedule

To ensure long-term commitment, align stakeholder interests, and maintain market stability, the following vesting schedule will apply to the UFCA token allocations. All vesting will commence from the Token Generation Event (TGE).



### **UFCA Token Vesting Schedule**

- IEO (15% 15,000,000 UFCA):
  - 100% unlocked at TGE.
- Scientific Research (AI ∞ Development) (20% 20,000,000 UFCA):
  - 6-month cliff.
  - Followed by linear monthly vesting over 30 months.
- Foundation (Including Shareholder Dividend) (20% 20,000,000 UFCA):
  - 12-month cliff.
  - Followed by linear quarterly vesting over 36 months.
- UIFCA Wealth Academy (Education & Research Development) (10% 10,000,000 UFCA):
  - 3-month cliff.
  - Followed by linear monthly vesting over 24 months.
- Charity (5% 5,000,000 UFCA):
  - 20% unlocked at TGE (1,000,000 UFCA).
  - The remaining 80% (4,000,000 UFCA) will have a 6-month cliff.
  - Followed by linear monthly vesting over 18 months.
- Operations (Daily Ops & Marketing) (30% 30,000,000 UFCA):
  - 10% unlocked at TGE (3,000,000 UFCA).
  - The remaining 90% (27,000,000 UFCA) will have a 3-month cliff.
  - Followed by linear monthly vesting over 24 months.

Transparency Commitment: All smart contracts governing these vesting schedules will be publicly audited and verifiable on the BNB Smart Chain explorer to ensure full transparency for our community and stakeholders.
